GREEN POWER SERVICE RIDER

SCHEDULE GPSR -5

I. AVAILABILITY

Available in all territory served by the Cooperative, in accordance with the Cooperative's Service Rules and Regulations.

II. APPLICABILITY

Subject to the Conditions of Service defined herein, Schedule GPSR is applicable as a rider for service to any customer under any of the Cooperative's standard rate schedules.

III. TYPE OF SERVICE

Single-phase or multi-phase, 60 hertz, at available secondary voltage.

IV. RATE-MONTHLY

The customer will be billed for all kWh consumed by the customer, including Green Power kWh, pursuant to the Cooperative's standard applicable rate schedules. The customer will purchase Green Power in monthly units or blocks as defined below:

- A. Full Block (150 kWh) \$4.50 per month plus applicable charges
- B. Partial Block (100 kWh) \$3.00 per month plus applicable charges

In addition to the standard rate charges, the customer will be charged the flat rates outlined above for each full and half block of Green Power purchased by the customer. The amount charged for each Green Power full and half block will support the continued use and development of Green Power.

All fees, charges and other costs outlined in the applicable retail rate schedule shall apply, including, if applicable, Wholesale Power Cost Adjustments (WPCA) as outlined in rate Schedule "R".

V. CONDITIONS OF SERVICE

Service hereunder will be subject to the following conditions:

- A. The customer may be required to execute an agreement to purchase a specified number of Green Power blocks for a minimum of 12 consecutive months.
- B. The agreement will automatically renew each year on the anniversary date of the agreement unless canceled by the customer by giving the Cooperative notice in writing at least 30 days prior to the anniversary date of the agreement. The customer will remain obligated to pay for those Green Power blocks purchased by the customer through the term of the agreement.
- C. The amount(s) shown herein will be billed on a monthly basis as described herein or as may be amended by the Board of Directors.
- D. The customer agrees that the Cooperative may, at its sole discretion, change, alter or eliminate completely any aspect or the entire program described herein.

VI. WHOLESALE POWER COST ADJUSTMENT

As noted in Section IV, Rate-Monthly, all usage actually measured at the meter shall be subject to the provisions of the Cooperative's Wholesale Power Cost Adjustment Schedule "R", when applicable.

The Wholesale Power Cost Adjustment (WPCA) shall be computed based on the actual energy consumed by the customer during the billing month.

VII. FRANCHISE FEE, GROSS RECEIPT OR OCCUPATION TAX

Any tax or franchise fee, gross receipt or occupation tax imposed by any governmental authority upon the service, or any component thereof, rendered under this Schedule will be added to bills calculated pursuant to the above rate.

VIII. TERMS OF PAYMENT

The bill is due upon receipt and payable within ten (10) days thereafter.
